

CHEVROLET 'TEST, DRIVE & WIN' CONTEST

CONTEST FAQ

1. What is the duration of the contest?

The contest duration is from 1st Jun – 30th September 2017

2. How does the contest work?

From 1st June 2017 - 30th September 2017, test drive any of your preferred new Chevrolet model at ANY Chevrolet showroom and stand a chance to be in the running to win the Grand Prize – All expense paid trip for 2 pax to London and Manchester United match tickets at Old Trafford, UK; monthly 1st Prize – Apple iPad Mini, 2nd Prize – Suunto Traverse Watch, 3rd Prize – RM450 Petrol Card. Fill in the form, with proof of test drive indemnity agreement attached.

3. How to participate in the campaign?

- a. Visit the nearest authorized Chevrolet dealer.
- b. Test drive, book or register any Chevrolet model in between of 1st June – 30th September 2017.
- c. For test drive, you'll receive 1 contest form; for booking, 3 contest forms and upon registration, 5 entry forms.
- d. Fill up the contest form, answer the question correctly and complete the slogan.
- e. Attach the contest form with proof of test drive indemnity agreement / booking / registration receipt attached.
- f. Submit the completed contest form to the Sales Advisor

3. Who can participate?

The Contest is open to all Malaysian residents aged 18 years and above. The following group of persons shall not be eligible to participate in this promotion; employees of the organiser including its affiliated and related companies, distributors, representatives, vendors, sponsors and/or agents of advertising and/or promotion service providers of the organiser including its affiliated and related companies and their immediate family members.

4. Where can I participate?

Customer can participate in this contest at the authorized Chevrolet dealer or roadshow where test drive, booking and registration activities can be held.

5. Chevrolet models eligible to participate in the campaign?

The eligible models are Chevrolet Malibu, Chevrolet Cruze, Chevrolet Orlando, Chevrolet Sonic & Chevrolet Colorado.

6. Can I test drive more than 1 unit of Chevrolet during this campaign period?

Yes. There is no limit to how many test drives an individual wants to secure.

7. If I test drive more than 1 unit of Chevrolet, does it increase my chances to win the grand prize?

Test drive more than 1 unit of Chevrolet will increase your chances as you will be given ONE (1) contest entry form for every unit you test drive for. However, test drive MUST be made before 30th September 2017 to be eligible to be in the running for the Grand Prize and monthly prizes.

8. How many contest entry forms am I entitled to submit after participating in the activities?

Customer can only submit one (1) entry per month provided that each entry submitted is of different model.

- i. One (1) test drive is eligible for ONE (1) contest entry form – with proof of test drive indemnity agreement
- ii. One (1) booking is eligible for THREE (3) contest entry forms – with proof of booking receipt
- iii. One (1) registration is eligible for FIVE (5) contest entry forms – with proof of VSO attached

9. If I do not register my vehicle during the contest period, am I still eligible for five (5) entry forms?

No. The car did not register during the stipulated contest period hence will automatically count as booking entry with three (3) contest entry forms.

10. How many grand prize winner & monthly winners are there for this contest?

- a) There will be only ONE (1) Grand Prize winner throughout the duration of this contest.
- b) There will be THREE (3) monthly prize winners throughout the duration of this contest.

11. What is the grand prize for this contest?
